

What? Green Infrastructure and other Solutions

Green infrastructure refers to natural systems including forests, floodplains, wetlands and soils that provide additional benefits for human well-being, such as flood protection and climate regulation.

Gray infrastructure refers to structures such as sewers, pipes, roads, water treatment plants, dams, seawalls, or roads.



Review of Topographic Wetness

- What is topographic wetness?
 - We live in a flat landscape
 - Stormwater moves slowly when it doesn't have hills to run down
 - Stormwater collects and pools
 - The Topographic Wetness Index helps us understand where water may collect and pool based on a community's elevation changes

Review of Topographic Wetness

- Why does it show a flood zone in my neighborhood when I don't experience flooding?
 - This map assumes that the sewer system is at capacity (e.g., large storms) and then looks at where water would collect and pool in that scenario.
 - It can be used to predict high-risk flood areas during large storms or when sewers are not draining properly
